5. Pre-bid meeting shall be held at 14:00hr on 2074/02/12 at Bhojpur District Court, bhojpur.
6. Sealed or electronic bids must be submitted to the office Bhojpur District Court, bhojpur by hand/courier or through PPMO website www.bolpatra.gov.np on or before 12:00 pm on 2074/02/22. Bids received after this deadline will be rejected. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2074/02/22 at the office of Bhojpur District Court, bhojpur
7. All bids shall be accompanied by a Bid Security for the amount and validity period as specified in the above table. Bidders are required to submit a separate bid security for each contract for which they submit the bids. The bid security guarantee shall conform to the standard format as specified in the bid document. The bid security guarantee issued only by commercial banks approved by Nepal Rastra Bank shall be accepted
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The employer reserves the right to accept or reject wholly or partly any or all the bids without assigning any reason.
10. Any intimidation, collusion and cartelling during bidding process shall be punishable by law.
