A complete set of bidding documents in English may be purchased by the interested bidders upon submission of a written application to the **Mustang District Court Mustang, Jomsom** and upon payment of a non-refundable fee Of Rs.3000.00. Bidding documents can be purchased within the office hrs **up to June 01<sup>st</sup>, 2017**

For the purpose of Bidders who choose to submit their bid electronically through E-bidding Portal PPMO Web Site <http://www.bolpatra.gov.np>, the Bidders may either purchase the hard copy of bidding documents or may choose to down load the necessary part of bidding documents, prepare their bids and submit their electronic bids as specified in the Instructions to Bidders. In case the Bidder chooses to download and submit bid electronically, the Bidder shall be required to deposit the cost of bidding document Rs. 3000.00 in the MDC Revenue account and electronic scanned copy (PDF format) of the Bank deposit voucher shall be submitted along with the electronic bid files.



5. Sealed Bids must be delivered to the **Mustang District Court, Mustang, Jomsom** on or **before 12:00 hrs of June 02<sup>nd</sup>, 2017**. Alternatively, bidders may submit their bid electronically through E- bidding Portal PPMO Web Site <http://www.bolpatra.gov.np> as specified in the Instruction to Bidders. Late bids will be rejected. Bids will be opened physically and electronically immediately after the bid submissions in the presence of the bidders' representatives who choose to attend in person at 13:00 pm hrs on the same day after bid submission deadline.
6. Pre-bid meeting will be held in the office of the **Mustang District Court , Mustang, Jomsom** at 13:00 pm. hrs on **May 17<sup>th</sup>, 2017**. Detail Information about submission process of bid electronically (e-submission) shall be provided to all interested bidders who choose to attend this pre-bid meeting.
7. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security amounting to a minimum of **210,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing, submission and opening falls on a government holiday, it shall be extended to the next working day.
