Invitation for Bids for the Construction of Judge Quarters Building

1. The **Rupandehi District Court, Bhairahawa Rupandehi** has allocated funds from **Supreme Court of Nepal** towards the cost of **Construction of Judge Quarters Building** and intends to apply part of the funds to cover eligible payments under the Contract for **Construction of Judge Quarters Building at Bhairahawa Rupandehi**, **Contract No.01/073/074**. Bidding is open to all eligible Nepalese bidders.
2. **Rupandehi District Court, Bhairahawa, Rupandehi** invites sealed bids or electronic bids from eligible bidders for the construction of **Above mentioned Work** under National Competitive Bidding – Two Envelope Bidding procedures. Under the Single-Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two sealed envelope, (i) one sealed envelope containing the Technical Bid and labeled " Technical proposal" and (ii) the other sealed envelope containing Price Bid only and labeled as "Price Bid". Both in turn enclosed in one sealed envelope as per the provision included in ITB 21 of Bid Document. The "Letter of Technical Bid" submitted with Technical Bid, and the "Letter of Price Bid" submitted with Price Bid in separately sealed envelopes must be signed by authorized signatory, failure to which may be the ground for declaring the bid nonresponsive.


Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years:
NRS 3,53,00,000.00.

Minimum Work experience of similar size and nature of at least **ONE** contract with a value of at least **NRS 2,36,00,000.00**
3. Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from

Bidders, submitting their bid electronically, should deposit the cost (as specified above) of bidding document in the Project's **Rajaswa (revenue) account** as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 5. Pre-bid meeting shall be held at **Rupandehi District Court , Bhairahawa, at 1 PM on 2074/02/28 B.S. (11th June, 2017).**
6. Sealed or electronic bids must be submitted to the office **Rupandehi District Court, Bhairahawa** by hand or through DUDBC website www.edudbc.gov.np . on or before **12:00 PM** on **2074/03/07 B.S. (21st June, 2017)**. Bids received after this deadline will be rejected.
7. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at **1 PM, 2074/03/07 B.S. (21st June, 2017)** at the office of **Bhairahawa**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum NRS **7,35,000.00**, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Other mandatory information will be as per Public Procurement Act and Regulation.
