If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost of NRs. **1,000.00**. However, the Employer will not be responsible for delay or non-delivery of the documents so sent.

4. Pre-bid meeting shall be held at District Court Salyan. *Salyan at 12:00 hours on 2074/1/18*
5. Sealed bids must be submitted to the District Court Salyan by hand/courier on or before *12:00 hours on 2074/1/18*. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend *at 1:00 hours on 2074/1/18* at the District Court Salyan. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security, amounting to a minimum of as stated in above table, which shall be valid for 30 days beyond the validity period of the bid (i.e. *2074/05/20*)
7. **Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non-responsive.**
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Bidders may obtain bid Notice By visiting Supreme Court website www.supremecourt.gov.np.
10. Right to accept or Reject to bid, Fully or partially depend on Salyan District Court. Other Rule which are not mention in this Notice are according to Public Procurement Act, 2064 and Regulation 2063. And Other rule and Regulation are according to law of Government of Nepal.
