If so requested, the Bidding Documents can also be sent by post/courier services upon payment of additional cost However, the Employer will not be responsible for delay or non-delivery of the documents so sent. Sealed or electronic Bids must be submitted to the office address below by hand/courier or through DUDBCs website <a href="www.edudbc.gov.np">www.edudbc.gov.np</a> on or before 12:00 hours (local time) on the date as mentioned above. Bids must be valid for a period of 90 days after bid opening date; must be accompanied by a Bid Security not less than as stated above and valid up to 2074-05-24 BS (120 days).
- Bids will be opened in the presence of the bidders representatives, who choose to attend in person at the address below at 13:00 hours (local time) on 2074/01/29 B.S.
- 8. In case the last date of purchase, submission or opening of Bid happens to be a government holiday it shall be extended to the next working day. In such case the Bid security validity period shall remain the same as specified for the original last date of Bid submission.
