1. The Government of Nepal (*GoN*) has allocated funds towards the cost of following **construction works**. Bidding is open to all eligible Nepalese and Foreign Bidders.
2. Bidders may bid for one or several contracts, as further defined in the Bidding Document. Bidders wishing to offer discounts will be allowed to do so provided those discounts are included in the Letter of Bid.
3. **Rasuwa District Court Office, Rasuwa** invites sealed bids or electronic bids from eligible bidders for the construction of

6. Pre-bid meeting shall be held at **District Court Office, Rasuwa** on **2076/01/29 13:00 Hrs.**
7. Sealed bids must be submitted to the office **Rasuwa District Court Office, Rasuwa** by hand before **as shown in the table below**. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **as shown in the table below** at the office of **Rasuwa District Court Office, Rasuwa**. Bids must be valid for a period of **90(Ninety) days** after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **as shown in the table below**, which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Any provisions which are not mentioned in this notice will be consistent with Public Procurement Act (PPA), 2063 / Public Procurement Regulations (PPR), 2064 and other prevailing Nepalese Laws
