7. If the last date of Pre-Bid meeting and Bid Opening day falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.

8. Bidders may submit modification or withdrawal prior to the deadline of bid submission. Once a Bid is withdrawn, bidder will not be able to submit another bid response for the same bid.
