- 1. The Supreme Court of Nepal invites electronic bids from eligible bidders for the procurement of Storage for Digitization under National competitive bidding procedures -Single Stage Two Envelope procedures specified in Public Procurement Act and Regulations.
- Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document.
- Eligible Bidders may obtain further information and inspect the bidding documents at the office of Supreme Court of Nepal, Ramshah Path, Kathmandu, www.supremecourt.gov.np, telephone No. 01-4200720 or may visit PPMO egp system www.bolpatra.gov.np/egp.
- Bidder who chooses to submit their bid electronically may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the following Rajaswa (revenue) account as specified below.

- 5. Pre-bid meeting shall be held at 13:00pm on 2080/11/13 the office Supreme Court of Nepal, Ramshah Path, Kathmandu.
- 6. Electronic bids must be submitted to the office Supreme Court of Nepal, Ramshah Path, Kathmandu through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12:00 PM on 2080/11/24. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 13:00 PM on 2080/11/24 the office of Supreme Court of Nepal. Bids must be valid for a period of 90 days from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 6,20,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
