1. **Government of Nepal has allocated funds** towards the cost of **Construction of Interior Works of Supreme Court New Building** and intends to apply part of the funds to cover eligible payments under the Contract **for Construction of Interior Works of Supreme Court New Building**. **Bidding** is open to all eligible as per Section V of bidding document.
2. **Supreme Court of Nepal invites** electronic bids from eligible bidders for the **Construction of Interior Works of Supreme Court New Building** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.
3. Eligible Bidders may obtain further information and inspect the Bidding Documents from PPMO e-GP system www.bolpatra.gov.np/egp.
4. Bidders shall download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders should deposit non-refundable cost of **Nrs. 20,000.00 (In words: Twenty Thousands rupees only)** for bidding document in the Project's Rajaswa (revenue) account as specified below

 6. Electronic bids must be submitted through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12.00 noon on **2083/03/01 (2026/06/15)**. Bids received after this deadline will be rejected.

Bids must be valid for a period of **120 Days** from the bid submission deadline and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **Nrs. 15,675,000.00** which shall be valid for 30 days beyond the validity period of the bid .

7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid and bid security shall remain the same as specified for the original last date of bid submission.
