In this regards, I would like to request you to recommend 4 eligible candidates in each courses according to the program guideline and program eligibility criteria along with 3 sets of Application Forms (of KOICA and Application package of respective University, which shall be shared soon) and send to KOICA Nepal office until given deadline. The qualification of the applicants is explicitly explained in "2021 KOICA Scholarship Program Application Guideline for Doctoral Degree" enclosed with this letter. However, it is mandatory that the recommended candidate must have successfully completed the Master's Degree Program from Korean University under KOICA's Scholarship Program. In the meantime the recommended candidate should not have taken part in any other Korean Government Scholarship Program (except of KOICA program). The recommended candidate has to go through series of interview including the local

interview organized by the KOICA Nepal Office in order to know the motive, willingness to study. The application submitted after the deadline will not be accepted.

Furthermore, I would like to inform you that the listed Master's courses are the open competition around the world, therefore KOICA office cannot assure about the confirmation from the University for the nomination made by the Government of Nepal. The final selection of the candidate solely depends on the applicant's performance in series of interview as well as final judgment of the respective University. Adding on, the timeline of selection process and date of entry to Korea, of the selected participants could be changed due to COVID 19 pandemic.

For your kind reference KOICA encourages female participation in each of its program, hence it is requested you to recommend more female participants. I thank you cooperation and support in this regards.

4. Qualifications

Prospective applicants must meet all of the following conditions.

- (1) Citizenship: Be a citizen of the Scholarship Program target country.
- (2) Government Nomination: Be a government employee.
 - (Preferably) With a minimum of 3 years of experience in the field of study after graduation from KOICA master's degree program.
 - * Exception 1 Applicants with a background in international development NGO may also apply, under the condition that he/she provide two recommendation letters from
 - -1) his/her government office; and
 - -2) the Korean Embassy, a world widely known NGO, an UN-associated organization, or the KOICA Overseas Office within your region.
- (3) AGE: (Preferably) Be under age 40 as of February 1, 2021.
- (4) Health: Be in good health, both physically and mentally.
 - Those with disabilities, but in good mental and physical health, are eligible to apply.
 - Those with severe illness are NOT ELIGIBLE to apply.
- (5) Level of Education: Be a master's degree holder from KOICA scholarship program
- by August 2021. (bachelor's degree is mandatory qualifications)
- (6) English Proficiency: Have a good command of both spoken and written English in order to take classes conducted entirely in English and to be able to write academic reports and theses in English.
- (7) Recommendation: A person recommended by both 1) a Korean university from which they have obtained a master's degree and 2) a currently employed organization





- 2. The requirements for applicants' degree and age are that applicants must:

be a high school graduate under the age of 25 when applying for the undergraduate programs;

be a bachelor's degree holder under the age of 35 when applying for the master's programs;

be a master's degree holder under the age of 40 when applying for the doctoral programs;

be under the age of 45 and have a high school diploma (or higher) when applying for the general scholar programs;

be a master's degree holder or an associate professor (or above) under the age of 50 when applying for the senior scholar programs.

V Application Procedure

- Step 1 Apply to the dispatching authorities for overseas study of your home country for CGS opportunity;
- Step 2 Apply to your target university for the Pre-admission Letter once recommended by the dispatching authorities as an eligible candidate (you will receive an Award Letter for CGS Candidate);
- Step 3 Complete the online application procedure at CGS Information Management System for International Students (Visit http://www.csc.edu.cn/studyinchina or http://www.campuschina.org and click "Application Online" to log in), submit online the completed Application Form for Chinese Government

Scholarship, and print a hard copy. You should consult the dispatching authorities for overseas study of your home country for Instructions of CGS Information Management System for International Students and Agency Number;

Step 4 - Submit all of your application documents to the dispatching authorities of your home country before the deadline.

NOTE

Only applications of recommended candidates from dispatching authorities will be considered. Candidates holding a Pre-admission Letter will be placed in the host university; those without the Pre-admission Letter should accept CSC's placement of university.

VI Application Documents

- a) Application Form for Chinese Government Scholarship (in Chinese or English).
- b) Copy of Passport Home Page: Applicant shall submit a clear scanned copy of his/her ordinary passport with validity later than March 1, 2022. If the validity of the current passport does not meet the requirement, please apply for a new passport before submitting the application. For applicants who cannot apply for passports before submitting their applications due to objective reasons, with the permission of dispatching authorities, they may submit scanned copy of identity certificates or official documents containing the applicants' "English name, Gender, Nationality, Date of Birth" and other information.
 - c) Notarized highest diploma: Prospective diploma winners must submit official proof of student status by their current school. Documents in languages other than Chinese or English must be attached with notarized Chinese or English translations.
 - d) Academic transcripts: Transcripts in languages other than Chinese or English must be attached with notarized Chinese or English translations.
 - e) A Study Plan or Research Proposal in Chinese or English. (A minimum of 200 words for undergraduates, 500 words for non-degree students, and 800 words for postgraduates.)
 - f) Recommendation letters: Applicants for graduate programs or senior scholar programs must submit two letters of recommendation in Chinese or English from professors or associate professors.
- g) Applicants for music studies are requested to submit their own works. Applicants for fine arts programs must submit their own works which include two sketches, two color paintings and two other works.
- .) Applicants under the age of 18 should submit the valid documents of their legal guardians in China.
- i) Applicants planning to stay in China for more than 6 months must submit a photocopy of the Foreigner Physical Examination Form completed in English (the original copy should be kept by the applicant. The form is designed by the Chinese quarantine authority and can be obtained from the dispatching authority. The physical examinations must cover all the items listed in the Foreigner Physical Examination Form. Incomplete records or those without the signature of the attending physician, the official stamp of the hospital or a sealed photograph of the applicants are invalid. Please select the appropriate time to take physical examination as the result is valid for only 6 months.
- j) Non-criminal record report. The applicant shall submit a valid certificate of Non-Criminal Record issued by the local public security authority, usually issued within 6 months prior to the submission date of the application. Please submit the following documents if applicable

- k) Pre-admission Letter from Chinese Government Scholarship universities.
- I) Language qualification certificate. e.g., HSK certificates, IELTS or TOFEL report.

Reminder: All uploaded supporting documents must be clear, authentic and valid. Applicants are recommended to use professional device to scan the relevant documents. Applicants shall bear the consequences caused by unclear or unidentifiable uploaded materials.

VII Placement & Scholarship Confirmation

- 1. Application documents of recommended candidates from dispatching authorities will be conside. ____, CSC for eligibility and qualification. Ineligible or incomplete applications will not be considered.
- Qualified applications will be sent to universities for placement. Based on various factors, such as the different scholarship funding requirements of every country, the host university's teaching capacity, study length and applicants' criteria, CSC reserves the right to make necessary adjustments/changes to the candidate's host university, field of study, supporting categories and duration of scholarship. Applications enclosed with the Preadmission Letter will be sent to the universities who issued that Letter for placement confirmation.
- After placement confirmation by Chinese universities, scholarship Recipients will get Chinese government scholarships to study in China with approval by CSC. Each scholarship recipient will be granted with no more than one scholarship.
 - CSC reviews the placement results, approves the List of Scholarship Recipients and sends the admission documents to the Chinese embassy or consulate-general before July 31st. The Chinese embassy or consulate-general will send the admission documents (*List of Scholarship Recipients, Admission Letter* and *Visa Application Form for Study in China (JW201)*) to the dispatching authorities or scholarship recipients.
- 5. Scholarship recipients shall not allowed to change their host university, field of study, or duration of study stipulated on the *Admission Letter* after their coming to China.
- 6. Scholarship will not be reserved if the scholarship recipient cannot register before the registration deadline.
