1. The Supreme Court of Nepal invites **sealed** bids from eligible bidders for **End Point Security for Servers** under National competitive bidding procedures - **Single Stage Two Envelope procedures** specified in Public Procurement Act and Regulations.
2. Under the **Single Stage, Two Envelope Procedure**, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 23.1 (a) of the Bidding Document.

5. Pre-bid meeting shall be held at 13:00pm on **2079/11/21** the office **Supreme Court of Nepal, Ramshah Path, Kathmandu**.
6. Sealed bids must be submitted to the office **Supreme Court of Nepal, Ramshah Path, Kathmandu** by hand on or before **12:00pm** on **2079/12/06**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **13:00 PM** on **2079/12/06** the office of **Supreme Court of Nepal**. Bids must be valid for a period of **90 days** from the date of bid opening and must be accompanied by a bid security, amounting to a minimum of **NRs. 74,000.00**, which shall be valid for **30 days** beyond the validity period of the bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
