1. The Government of Nepal Arghakhanchi District Court has allocated funds from *Supreme Court of Nepal* towards the cost of *Construction of Judge Quarter Building* of the *Arghakhanchi District Court, Sandhikharka, Arghakhanchi* and intends to apply part of the funds to cover eligible payments under the Contract for *Construction of Judge Quarter Building of the Arghakhanchi District Court, Sandhikharka, Arghakhanchi, contract No.DAO/01/074/075*. Bidding is open to all eligible Nepalese and foreign bidders.
2. *Arghakhanchi District Court, Sandhikharka, Arghakhanchi* invites sealed bids or electronic bids from eligible bidders for the construction of **Above Mentioned Work** under National Competitive Bidding – Two Envelope Bidding procedures. Under the Single-Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two sealed envelope, (i) one sealed envelope containing the Technical Bid and labeled "Technical proposal" and (ii) the other sealed envelope containing Price Bid only and labeled as "Price Bid". Both in turn enclosed in one sealed envelope as per the provision included in ITB 21 of Bid Document. The "Letter of Technical Bid" submitted with Technical Bid, and the "Letter of Price Bid" submitted with Price Bid in separately sealed envelopes must be signed by authorized signatory, failure to which may be the ground for declaring the bid nonresponsive.
3. A complete set of Bidding Documents may be Purchased from the *Arghakhanchi District Court Office, Arghakhanchi*, Address: Sandhikhark, Arghakhanchi, by eligible Bidders on the submission of a written application, along with the copy of company /firm registration certificate, and upon payment of a non-refundable fee of 5000.00 till 2074/06/1 B.S. (17 Sept, 2017) Time 17.00 hrs.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from Web Site www.bolpatra.gov.np/egp Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 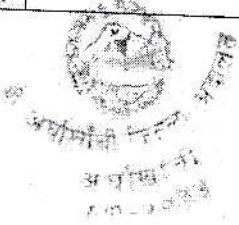

6. Sealed or electronic bids must be submitted to the Arghakhanchi District Court Office, Sandhikhark, Arghakhanchi, Address: Sandhikhark, Arghakhanchi, by hand or through PPMO website www.bolpatra.gov.np/egp on or before 12:00 PM on 2074/06/02 B.S. (18 Sept, 2017). Bids received after this deadline will be rejected.
7. The Technical bids will be opened in the presence of Bidders' representatives who choose to attend at 1 PM, 2074/06/02 B.S. (18 Sept, 2017) at the Arghakhanchi District Court Office, Sandhikhark, Arghakhanchi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum NRS 370000.00, which shall be valid for 30 days beyond the validity period of the bid.
8. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. The Bidder who will win the Bid is responsible to take away and/or dispose of or use personally the materials of the old buildings and the marked trees situated at the construction site and he/she shall pay the cost equivalent to the Valuated Amount of Rs. 4,01,649.40 For this purpose, the Bidders shall deposit the said amount (Refundable to Bidders except Bid winner) in Deposit (Dharaut) Account No. 3050203000000 Ko Le Ni Ka of the Arghakhanchi District Court, Sandhikhark, Arghakhanchi at Rastriya Banijya Bank, Sandhikhark Branch, Arghakhanchi and submit the bank deposit voucher along with the Bid documents. Bidders, submitting their bid electronically, should deposit the cost of the materials of old buildings and trees in the said Deposit (Dharaut) account and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.
10. Other mandatory information will be as per Public Procurement Act and Regulation.
