Chip Level Officer will be working as the maintenance and repairmen of all types of IT Hardware. S/he will control all system/maintenance/support activities. Chip level officerwill report IT Manager for the maintenance and repair of all IT devices or equipment or hardware; and should be the expert of computer hardware/system/network maintenance.

Bachelor in Information Technology or Equivalent with 3+(Three Plus) years experience. (Preference will be given to Candidates with professional Certification).

(ग) आवश्कता (Requirements)

- Good knowledge of Computer Hardware.
- Proficient understanding of code versioning tools, such as Git, SVN.
- Ability to quickly grasp new tools & technology and self-learning.
- Excellent written and verbal communication skills.
