In order to strengthen mutual understanding and friendship as well as deepen practical cooperation among the legal professionals in Eurasia, China Law Society is going to hold the Course of the Belt & Road Eurasia Legal Exchange Program from September 14 to 25, 2020.

China Law Society is the largest nationwide legal academic organization in China. It assembles elites in legal field from all over the country, and has close working relationships with judicial organs, prosecutorial organs, law firms, law schools and legal departments of enterprises. China Law Society is also the main channel of international legal exchange.
