A complete set of Bidding Documents may be purchased from *Kailali District Court, Dhangadhi Sub-metropolitan City* by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee as mentioned above. If so requested, the Bidding Documents can also be sent by post/courier services. However, the Employer will not be responsible for delay or non-delivery of the documents so sent. Or Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may down load the bidding documents for e-submission from www.edudbc.gov.np. Bidders, submitting their bid electronically, should deposit the cost(as specified above) of bidding document in the Project's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 

4. Sealed or electronic bids must be submitted to Kailali District Court, Dhangadhi as mentioned above. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidders' representatives who choose to attend at 1pm, 2074/01/07 at Kailali District Court, Dhangadhi. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security from commercial bank of Nepal or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs 2,06000, which shall be valid for 30 days beyond the validity period of the bid i.e. 2074/05/02.
6. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. The bidders who submit bids through e-bid must submit the original copy (Hard copy) within 7days from the last date of bid submission
8. Other mandatory information as per PPA and PPR.
